## **1098-T FAQs - ECSI**

If Box 7 is checked the student's 1098-T is for all qualified tuition charges or payments received or made for the beginning of next year's reporting period (January through March). Box 1 and Box 2 do not and should not include amounts for courses where no course credit is issued or any courses involving sports, games and hobbies.

What is IRS Form 1098-T? An eligible educational institution, such as a college or university in which you are enrolled, and an insurer who makes reimbursements or refunds of qualified tuition and related expenses to you must furnish this statement to you.
